Initial Set up Fee to become Registered Agent only – You prepare and file Certificate of Incorporation/Certificate of Formation, includes our registered agent fee for the remainder of the current calendar year	\$125
Annual Registered Agent Fee – You will be billed the Annual Registered Agent Fee in conjunction with the mailing of the State of Delaware Annual Franchise or LLC Tax Report	\$125
Mail Forwarding Service – First class mail only. Up to 10 pieces per month. Additional postage deposit may be required for larger/heavier mail	\$300
Basic LLC Formation – Prepare and file our customary Certificate of Formation	\$300
Basic Incorporation – Prepare and file our customary Certificate of Incorporation	\$425
Standard Incorporation Package:	\$650

Corporations and LLCs

- All formation and incorporation services above include the Initial Set-up Fee and state filing fees.

Corporations

- Our customary corporation has 1000 shares at \$.01 par value. If you require a different capital structure, please contact us to discuss the fees involved. The Bylaws, Statement of Incorporator and Initial Consent of Directors establish your company’s officers and directors and are drafted using our standard forms. In addition, you would need to pay additional fees if there are excessive out-of-pocket expenses which we incur such as expenses for certified copies, postage, telephone, complex document preparation and reproduction, and governmental filing fees charged by the State of Delaware. The State provides expedited filing and return of the documents for an additional charge. We can give you that information if you need to file on a rush basis.

We reserve the right to change our fees and amend this schedule without prior notice.

SECRETARY OF STATE
EXPEDITED SERVICES FEES

One Hour Service - \$1,000

Completed within one hour of receipt. Filing must be received by 9 p.m. EST or EDT.

Two Hour Service - \$500

Completed within two hours of receipt. Filing must be received by 7 p.m. EST or EDT.

Same Day Service – \$100

Must be received before 2 p.m. EST or EDT.

24-Hour Service - \$50

Request must be completed within 24 hours of receipt, excluding weekends and holidays.
Filing must be received by 7 p.m. EST or EDT.

NOTE: This is the time the Secretary of State takes to file the document. It is still another 24 hours to overnight the documents to us via Fed Ex charged to our account. We can send a courier which is also an extra charge.
